# Immunizations

## HEALTH & SAFETY



### Eligibility:

- 18 years old or younger AND
- Have no health insurance
- **OR** are enrolled in Medicaid
- **OR** are American Indians or Alaskan Natives

### Requirements:

- **MUST** bring child's most current immunization records
- The legal guardian must accompany each child and bring a photo ID
- If the legal guardian is not the parent, official documentation of legal authority must be shown. (Ex: Step parents or grandparents)

### Dates:

**September 11, 2017**

**Times: 1:00 to 5:00pm**

**3:00 to 5:00pm: Walk-ins**

## SALUD Y SEGURIDAD



### Elegibilidad:

- Es menor de 18 años de edad Y...
- No tiene seguro medico
- O tiene Medicaid
- O es un Indio Americano o nativo de Alaska

### Requisitos:

- Se requiere que el padre/madre o tutor legal acompañe el niño y lleve identificación con foto
- Si el tutor legal no es un padre, hay que mostrar documentación oficial de tutoría (ej.: Padrastro/Madrastra, abuelos)
- Se REQUIERE el registro de vacunas actualizado de cada niño, aún si no necesita vacunas.

**3:00 a 5:00pm: se aceptan sin cita**
